## **Terms & Conditions of Exhibitor Space Agreement**

- **I.** <u>Eligible Exhibits</u>. The Southern Tier Home Builders & Remodelers Association reserves the right to decline or prohibit any products, services, giveaways, contests and further reserves the right to reject any reservations and cancel any space agreement before or after assignment and/or acceptance if at the sole discretion such action is deemed in the best interest of the show.
- **II.** <u>Limitation of Liability</u>. The exhibitor agrees to make no claim for any reason whatsoever against the association and or show sponsors or hosts including claims for loss, theft, damage, or destruction of goods, nor injury to themselves or employees while setting up, while show is in progress, or move out. Exhibitor agrees to indemnify and hold harmless the Association, show sponsors, hosts, and the facility wherein the show is held and their employees against all claims of any person, arising out of acts, omissions or negligence of exhibitor, its agents, or employees.
- **III.** <u>General Liability Insurance</u>. The exhibitor is required to insure against fire, theft, liability, and all risk of loss, and should do at their expense. The Certificate of Liability Insurance **MUST** be in the minimum amount of \$1,000,000.00. The certificate MUST LIST Southern Tier Home Builders & Remodelers Association (STHBRA) as an additional insure with the dates of the show, April 19-21, 2024. The dates include the days of set-up through tear-down.
- **IV.** <u>Deposits & Payments</u>. \$100 per booth is required as a deposit (non-refundable) to reserve a space. 50% of booth balance is due by Friday, January 5, 2024. The balance is due by March 29, 2024.
- **V. <u>Cancellation</u>**. Exhibitors can cancel a reservation with a written notice. Any cancellations that are made before March 1<sup>st</sup>, 2024, will forfeit their \$100 per booth non-refundable deposit any additional payments will be refunded. Any cancelations made on or after March 1, 2024, will forfeit <u>all</u> deposits and payments.

### **CONDITIONS:**

- Exhibitor shall not assign, sublet or apportion the whole or any part of its allotted reserved space, nor display any goods or services other than those manufactured or sold by the exhibitor in the regular course of business.
- Exhibitor agrees to comply with any and all applicable law, rules, regulations, ordinances, licensing and copyrights.
- Exhibitor agrees not to dismantle nor remove any part of their display until the closing of the show.
- Exhibitor agrees to man assigned space throughout the show hours, maintain the space in good order and surrender such space in the same condition it received it before the show began.
- Exhibitor agrees that its failure to comply with the Association's shows' terms and conditions will result in the forfeiture of all deposits and payments and rights to the reserved space.
- Cash and carry is encouraged by exhibitor must adhere to the New York State Sales tax requirements and are the responsibility of the Exhibitor.
- Any Exhibitors interested in a displays with water must have STHBRA's approval. There is a self-contained water limitation.
- No flammable liquids or balloons are allowed in the display.
- Any signs and displays must be kept within the confines of the designated booth space.
- No soliciting or placing literature outside your designated booth space including cars in parking lot.
